WHILE MONITORING A SPECIAL DETAIL EVENT IN MAURICE A. FERRE PARK (1075 BISCAYNE BLVD) CITY OF MIAMI POLICE SERGEANT AT ARMS IBM: APPROACHED OFFICER VIERA IBM:43724 AND I IN REFERENCE TO AN ORGANIZED GROUP APPROACHING THE EVENT. THE OFFICERS ON SCENE AND I OBSERVED SAID ORGANIZED GROUP OF INDIVIDUALS CONSISTING OF APPROXIMATELY FIVE INDIVIDUALS WEARING CHICKEN SUITS WITH MULTIPLE SHIRTS IN HAND AND APPROXIMATELY FIVE OTHER INDIVIDUALS WALKING WITH THE GROUP RECORDING THEIR ACTIONS. DURING THE EVENT, WHILE A SPEECH WAS IN PROGRESS, THE GROUP DRESSED AS CHICKENS BEGAN TO WALK IN BETWEEN THE CROWD. ALSO, WALKING IN BETWEEN ROWS OF SEATS AS PEOPLE WERE WATCHING AND LISTENING. DISTURBANCE AND DISRUPTING THE EVENT FOR BOTH ATTENDEES AS WELL AS PERSONS WORKING THE EVENT. THESE CALCULATED ACTIONS CAUSED EVERYONE TO TURN THEIR ATTENTION TOWARDS THE DISRUPTIVE GROUP. THE PARK MANAGER (FRANK) AND SECURITY MANAGER (DANIEL) APPROACHED THE OFFICERS ON SCENE, NOTIFYING US THAT THE GROUP WAS NO LONGER WELCOME ON THE PREMISES DUE TO THE EVENT BEING DISRUPTED BY THEIR ACTIONS AND BEHAVIOR. SERGEANT AT ARMS AND OFFICER VIERA APPROACHED THE GROUP (BOTH THE ONES DRESSED AS CHICKENS AND THE INDIVIDUALS THAT WERE WITH THEM AND FILMING THEM) TO ISSUE THEM A TRESPASS WARNING. UPON THE SERGEANT AND OFFICER VIERA ISSUING VERBAL TRESPASSING WARNINGS AND COMMANDS TO THE ORGANIZED GROUP TO EXIT THE PREMISES AND STAND ONTO THE SIDEWALK, THE DEFENDANT WALKED IN THE OPPOSITE DIRECTION OF THE SIDEWALK. HE CONTINUED TO WALK IN-BETWEEN THE CROWD OF PEOPLE WHILE HANDING OUT T SHIRTS. SERGEANT AT ARMS / . AND I APPROACHED THE DEFENDANT TO WHICH SERGEANT / , GAVE THE DEFENDANT A VERBAL COMMAND TO EXIT THE PREMISES AS HE IS BEING TRESPASSED. THE DEFENDANT BEGAN TO ASK WHY AND DEMAND A REASON AS TO WHY HE IS BEING TRESPASSED FROM THE PROPERTY. WHILE IN THE PROCESS OF WALKING WITH THE DEFENDANT TOWARDS THE SIDEWALK THE DEFENDANT ONCE AGAIN STOPPED WALKING, REMAINING ON THE PREMISES OF THE PROPERTY AND BEGAN TO ASK WHY HE IS BEING TRESPASSED. SERGEANT AT ARMS ADVISED THE DEFENDANT THAT HE IS BEING TRESPASSED FROM THE PROPERTY AND REFUSAL WILL LEAD TO HIM BEING SUBJECT TO ARREST. THE DEFENDANT ONCE AGAIN REMAINED ON THE PROPERTY REFUSING TO EXIT. SERGEANT AT ARMS / AND I ATTEMPTED TO PLACE THE DEFENDANT IN HANDCUFFS TO AT WHICH POINT THE DEFENDANT BEGAN TO ACTIVELY RESIST BY TENSING HIS ARMS MAKING THE HANDCUFFING PROCESS DIFFICULT, ONCE AGAIN THE DEFENDANT BEHAVIOR DISRUPTED THE EVENT. ONCE THE DEFENDANT WAS PLACED IN HANDCUFFS AND UNDER ARREST, AS OFFICER VIERA AND I GUIDED THE DEFENDANT TOWARDS MY MARKED CITY OF MIAMI POLICE VEHICLE #216742 THE DEFENDANT CONTINUED TO ACTIVELY RESIST BY ALTERNATING STIFFING HIS LEGS THEN ATTEMPTING TO WALK IN THE OPPOSITE DIRECTION. DEFENDANT WAS PLACED INSIDE MY POLICE VEHICLE WITHOUT FURTHER INCIDENT AND TRANSPORTED TO TGK.
